## **GENERAL INFORMATION**

SUPRA-EDTA LIQUID ZINC is specifically formulated for use in high phosphate materials such as polyphosphates or phosphoric acid. It is a proprietary blend of a soluble metal in an aqueous solution.

SUPRA-EDTA LIQUID ZINC is designed for soil application. Foliar applications can be made as a micronutrient constituent of a foliar fertilizer or at the rate of 1 to 2 pints per acre with a minimum of 20 gallons of water throughout the growing season. It is compatible with most pesticides. Always make a small-scale test to assure compatibility.

## **DIRECTIONS FOR USE**

A specific mixing sequence must be followed when adding **SUPRA-EDTA LIQUID ZINC** to Ammonium Poly Phosphate (APP) solutions, Phosphoric Acid and APP/nitrogen solution combinations.

- APP & Phosphoric Acid Solutions: partially fill tank with APP, add SUPRA-EDTA LIQUID ZINC and complete filling process.
- APP/Nitrogen Solutions: always add SUPRA-EDTA LIQUID ZINC direct to APP solution followed by nitrogen solution.

Minimum agitation is suggested for thorough distribution.

### **RECOMMENDED RATES:**

The optimum rate and timing of application will depend on local conditions and should always be made as a result of soil and/or plant tissue analysis in consultation with your local agricultural authorities. In the absence of test results, use the following as a guide: Broadcast:

In-Row Starter/No Till: Use at the rate of 2 qts. per acre in a 2" X 2" in-furrow placement or banded over the row at planting.

This product may be corrosive to aluminum, mild steel and brass. Store in HDPE, fiberglass or stainless steel containers. Use only stainless steel, P.V.C. or polypropylene fittings. Storage: Store in a cool place in original container in a locked storage area inaccessible to children, pets, domestic animals or wildlife. Container Disposal: Do not reuse empty containers. Triple rinse (or equivalent) then offer for recycling or disposaby procedures approved by state or local authorities.
