In order to improve the appearance of turf, **SUPRA T&O 62 Green** is used as a supplement to fertilizer programs by incorporating a stabilized source of nitrogen and a more available form of iron. **SUPRA T&O 62 Green** can be used to help promote a darker green color in plants.

DIRECTIONS FOR USE

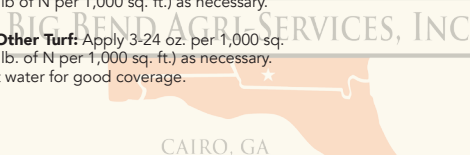
SUPRA-T&O 62 Green will disperse in water with minimal agitation. It can be tank mixed with most pesticides. Always make a small-scale test to assure compatibility. Use of a surfactant is recommended when applying to plants with waxy leaf surfaces.

Follow the mixing sequence: 1. Water; 2. **SUPRA T&O 62 Green**; 3. Other fertilizer; 4. Pesticide. Most liquid fertilizers will mix easily with **SUPRA-T&O 62 Green** at normal fertilizer rates. When combining **SUPRA-T&O 62 Green** with phosphate fertilizers maintain vigorous agitation to ensure good product mixing.

RECOMMENDED RATES

Turf (Greens and Tees): 3-10 fluid oz. per 1,000 sq. ft. (0.03-0.10 lb of N per 1,000 sq. ft.) as necessary.

Fairways & Other Turf: Apply 3-24 oz. per 1,000 sq. ft. (0.03-0.25 lb. of N per 1,000 sq. ft.) as necessary. Use sufficient water for good coverage.
