GENERAL INFORMATION

SUPRA-T&O Green Up is a highly effective foliar nitrogen, magnesium, manganese and iron formulation. **SUPRA-T&O Green Up** is designed to provide optimum color and plant health when used in a light-frequent feeding program on turf and ornamental plants.

DIRECTIONS FOR USE

SUPRA-T&O Green Up will disperse in water with minimal agitation. It can be tank mixed with most pesticides and fertilizers. Always make a small-scale test to assure compatibility. Follow the mixing sequence: 1. Water; 2. **SUPRA-T&O Green Up**; 3. Other fertilizer; 4. Pesticide. Spray volumes should not exceed 25 gal per acre due to the possibility of excessive run-off.

RECOMMENDED RATES

Turfgrass: Starting in the early spring, apply 7-16 fluid oz. per 1,000 sq. ft. every 4 weeks or as needed.

Greens, Tees, Fairways: Apply 7-16 fl. oz. per 1,000 sq. ft. in no less than 2 gal. of diluted mix per 1000 sq. ft. Can be applied every 7-21 days or along with a summer disease program.

Trees, Shrubs: For deep root feeding, mix 1-5 gal. per 100 gal of water. Inject 1-5 gal per inch of trunk diameter at chest height.

This product may be corrosive to aluminum, mild steel and brass. Store in HDPE, fiberglass or stainless steel containers. Use only stainless steel, P.V.C. or polypropylene fittings. **Storage:** Store in a cool place in original container in a locked storage area inaccessible to children, pets, domestic animals or wildlife. **Container Disposal:** Do not reuse empty containers.
