### GENERAL INFORMATION

**NITRO-Cal** is a concentrated aqueous solution that is designed for addition to soluble X-O-X grade fertilizers and will provide a highly soluble fertilizer that can be applied via aerial and ground applications. **NITRO-Cal** is very effective as a foliar spray to prevent and correct zinc deficiencies on fruit and other crops. **NITRO-Cal** will lower the pH of water in a spray tank from 7.4 to approximately 6.0 when it is added before other materials at a rate of 1 quart per 500 gallons of water. It is **IMPORTANT** that a non-ionic surfactant be added to aid in surface coverage which helps leaf absorption.

#### WHAT TO DO IN CASE OF CONTACT

### DIRECTIONS FOR USE

#### Ground Foliar Applications:

- Diluted – use a minimum of 100 gallons of water per acre;
- Concentrated – use a minimum of 20 gallons of water per acre
- When using less than 50 gallons of water per acre it is recommended to use a non-ionic surfactant.

**Aerial Applications** – use in at least 5 gallons of water per acre with the addition of a non-ionic surfactant. Apply with aircraft equipped with Beco-Mist type nozzles only.

- (1) When using with a citrus spray oils of the 435 class, surfactants are not needed.
- (2) Do Not use with liquid fertilizer that contains phosphates.
- (3) A jar test to check the compatibilities of combinations should be performed prior to mixing and application.

### RECOMMENDED RATES:

**FIELD CROPS:** (Corn, peanuts, soybeans, small grains, cotton); Apply 1 pint per acre in enough water to cover. At least 3 applications are suggested with additional applications being necessary for more severe deficiencies.

**FRUIT AND NUT TREES:** (Pecans, Citrus, Mangos, Avocados)

**MATURE TREES:** Apply 1-2 pints per acre in enough water to cover. Repeat application if desired at 1 pint per acre in summer and fall application.

**YOUNG TREES:** Apply 1 quart per 100 gallons of water and wet thoroughly. Applications every 6-8 weeks throughout the growing season have given excellent results. Do Not Use on Stone Fruit.

**VEGETABLE CROPS:** Apply 1/2 pint per 100 gallons of water.

**TURF, GREENS, TEES:** Apply 1/3-1/2 ounce per 1000 sq. ft. in enough water to cover. Repeat as needed.

**FAIRWAYS:** Apply 1-2 pints per acre in enough water to cover. Repeat as needed.
