GENERAL INFORMATION

SUPRA-KEY MZC Mix is a complexed liquid micronutrient compound containing sulfur, iron, manganese and zinc. It is designed for foliar and soil application for prevention and correction of micronutrient deficiency. It is recommended for use as an additive in liquid or dry fertilizers. It is compatible with most agricultural pesticides. **SUPRA-KEY MZC Mix** tank-mixed in water will decrease alkaline hydrolysis associated with organo-phosphate pesticides.

SUPRA-KEY MZC Mix is not recommended for use with pesticides that are not compatible with acid materials. **DO NOT MIX WITH HIGH PHOSPHATE LIQUID FERTILIZERS.** Always make a small-scale test to assure compatibility.

DIRECTIONS FOR USE

SUPRA-KEY MZC Mix can be soil or foliar applied, broadcast or banded over the row. Foliar application is recommended when fast correction is desired. Use sufficient water for thorough and uniform coverage of foliage or soil. For best results use a non-ionic surfactant.

SUPRA-KEY MZC Mix will disperse in water with minimal agitation.

Follow the mixing sequence:

1. Water
2. SUPRA-KEY MZC Mix
3. Pesticide or fertilizer
